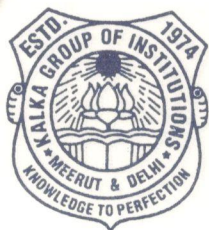
Notification

Duties and Responsibilities of Anti-Ragging Committee

In Compliance with the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009, and the directives of the Hon'ble Supreme Court of India, the Anti-Ragging Committee of Kalka Group of Institutions, Meerut shall be responsible for the following:

1. Policy Implementation

Ensure strict compliance with the UGC Regulations and Hon'ble Supreme Court directives to prohibit, prevent, and eliminate ragging. Formulate and review university policies to create a ragging-free environment on campus.

2. Preventive Measures

Conduct awareness campaigns and orientation programs for students, faculty, and staff on the ill effects and legal consequences of ragging. Publicize the anti-ragging policy through university websites, notice boards, prospectuses, and information booklets.

3. Monitoring and Supervision

Oversee and coordinate with the Anti-Ragging Squads and Mentoring Cells to ensure vigilant patrolling, especially in hostels, canteens, classrooms, and other vulnerable locations. Maintain regular interaction with hostel wardens and student representatives to monitor student behavior and grievances.

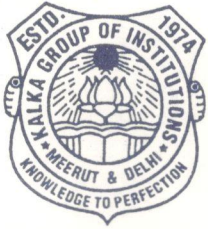
4. Complaint Handling and Redressal

Receive complaints related to ragging from students or other stakeholders and act promptly and sensitively. Ensure confidentiality and protection for complainants or witnesses against any retaliation. Conduct fair and impartial inquiries in coordination with the Anti-Ragging Squad. Recommend appropriate disciplinary action in proven cases, which may include suspension, expulsion, or filing an FIR, as per UGC norms.

5. Liaison and Reporting

Maintain liaison with local police, civil administration, and other statutory bodies as required. Submit regular reports on anti-ragging activities and incidents (if any) to the College authorities and the UGC Anti-Ragging Portal.

6. Documentation and Record-Keeping

Keep records of undertakings submitted by students and parents at the time of admission as per UGC regulations. Maintain a register of complaints received, action taken, and outcomes.

7. Support to Victims

Facilitate counseling and support services for victims of ragging. Ensure non-victimization of the complainant and provide academic and psychological support wherever required.

8. Meetings and Reviews

Conduct periodic meetings to assess the effectiveness of anti-ragging measures. Review and strengthen mechanisms and recommend improvements to the university administration.

Important guidelines:

It is mandatory for every student and their parent/guardian to submit duly signed affidavits at the time of admission, affirming that they will neither participate in nor tolerate any act of ragging. This order comes into immediate effect and will remain valid unless otherwise modified or replaced and is issued with the approval of the competent authority. All concerned are requested to extend their full cooperation and support to the Anti-Ragging Committee in the discharge of its responsibilities.
